## **Holiday Art & Craft Festival 2008** **November 28, 29 & 30, 2008**

You are invited to apply for the annual Holiday Art & Craft Festival 2008. The Festival hours will be Friday Nov. 28, 1 p.m. to 8 p.m., and Saturday & Sunday Nov. 29 & 30, 10 a.m. to 5 p.m. Last year's event was a huge success attracting 7,000 attendees and generating before-tax sales of more than \$200,000. We hope you'll consider joining us this year.

Last summer, the Crocker Art Museum began an expansion project that will triple the size of the current Museum. Due to ongoing construction we will again be at the Scottish Rite Masonic Center in east Sacramento. This venue is a single story building with room for more exhibitors, lots of free parking and easy access – all good things for our exhibitors as well as the buying public.

We are continuing our "booth fee plus 20% commission" format and have revamped our booth sizes.

- Deadline: Applications must be postmarked by July 1, 2008.
- Applications are also available on the Crocker website under the Special Events tab.
- Acceptance letters will be mailed the week of August 15, 2008.
- Enclose a \$10.00 check for administration and jury fee and a check for booth fee (only the booth fee will be returned to you if you are not accepted).
- Make all checks payable to the Crocker Art Museum Association.
- All fees are non-transferable and non-refundable after acceptance into the festival. Deposit of entry fee checks will be anytime on or after August 15, 2008.
- All entries must have four digital or photographic prints of your work (please label each print with your name) and a photo or sketch of your booth layout.
- Fine art and fine quality craft are accepted in addition to handmade gourmet food products. All work must be the artist's own original work. Reproductions must be signed, limited editions. No manufactured items will be permitted.
- Each participant is responsible for the set-up and teardown of their display.

Please send this completed application; photos of the works to be sold during the festival (please note: photos will NOT be returned); two separate checks made payable to the Crocker Art Museum for the \$10 jury fee and appropriate booth fees and table rentals. Applicants will be juried and notified of their selection by Aug 15. Jury fees will be processed at time of application, booth fees upon acceptance into the Festival. Only products submitted for jury approval will be permitted to be displayed at the event. Products other than those listed on the application will be removed from the booth. Food vendors must be prepared to provide proper health department certification.
